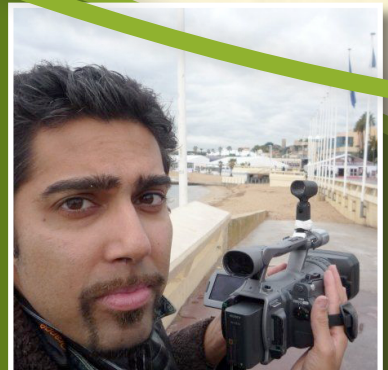

"I was diagnosed with multiple sclerosis in 2005 at the age of twenty-six. For the past few years, my ability to walk has been slowly deteriorating and my vision is getting worse.
